Training Slots under the India Technical Economic Co-operation (ITEC)
Scholarship Scheme of the Ministry of External Affairs, Government of India for
the year 2017 – 2018

The Government of India has allocated slots in the areas of capacity building & training diverse areas like IT, English Language, Management, Rural development, Finance, Mass Communication, Remote sensing etc. for Sri Lanka during 2018-2019 (1st April 2018 to 31st March 2019) under ITEC Indian Technical & Economic Co-operation (ITEC) in India.

All suitable applicants are now requested to fill their applications at the "Apply for ITEC/SCAAP course" link at the ITEC website (http://www.itecgoi.in/meaportal/registyerApplicant). Administration Officers could apply for the IT, English Courses and Management Courses, if they have Academic qualifications met with the required qualification laid down by the institute and 5 years working experience under Ministry of Home Affairs in the same position.

The hard copies (02 sets) of the applications should be submitted to the Development of External Resources along with the recommendation of the Ministry and the following documents at least three months before the commencement of the course.

- i. Duly filled ERD form No. 02 (Could be downloaded from www.erd.gov.lk)
- ii. Certified copies of the academic and professional qualifications.

A complete medical report should also to be submitted by the applicants to ensure their medical fitness by the doctors. Hospital/nursing home/clinic that are on the panel of the High Commission of India.

The guidelines, Course details, terms and conditions of ITEC/SCAPP, list of approved panel of hospitals could be downloaded from www.erd.gov.lk.

Once an ITEC Programme offered, the recipient is ineligible for any other ITEC Programme.
