1. **The Chairman, Cabinet Appointed Procurement Committee**, on behalf of the **District Secretariat - Kilinochchi** now invites sealed bids from eligible and qualified bidders for "Construction of Three Storied Building for District Secretariat at Kilinochchi - Stage II" as described below and estimated to cost of **Rs. 413.0 million** (Excluding VAT).
The scope of work: Construction of Three Storied Building.
The construction period is **728 Days**.
2. Bidding will be conducted through National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be registered in the field of **BUILDING CONSTRUCTION** for **Grade C2 or above** with the Construction Industry Development Authority (CIDA) and valid until the date of closing of the bids. Further registration should be valid at the date of award.

Bids shall be delivered or sent by registered post to the **Chairman, Cabinet Appointed Procurement Committee, Office of the Additional Secretary (Development), Development Branch, Home Affairs Division, Ministry of Internal and Home Affairs and Provincial Councils and Local Government, 15th Floor, "Nila Madura", Narahenpita Road, Colombo 05** to reach **on or before 10:00 hrs on 31-05-2019**. Late Bids will be rejected. Bids will be opened soon after closing at the Conference Room, Development Branch, Home Affairs Division, Ministry of Internal and Home Affairs and Provincial Councils and Local Government, 15th Floor, "Nila Madura", Narahenpita Road, Colombo 05 in the presence of the bidders' representatives who choose to attend.
7. Bids shall be valid for a period of 119 Days from the date fixed for closing of Bids.
8. All Bids shall be accompanied by a Bid Security which shall be;
 - in the form included in Section 11 in the Bidding document.
 - in favour of Secretary, Ministry of Internal and Home Affairs and Provincial Councils and Local Government.
 - for an amount of Rs. 4,500,000.00.
 - valid up to 24th October 2019
 - issued by one of the agencies indicated in the clause 17.2 of the Bidding Data.
